## INDEMNITY AGREEMENT

In Consideration of the City of Buena Vista giving the undersigned permission to use a portion of the public right-of-way, the undersigned agrees to assume the defense of and indemnify and save harmless the City, its employees, officers and agents from and against any and all claims, liabilities, judgements, costs, causes of action, damages and expenses, and to pay all attorney's fees, court costs and other costs incurred in defending any claims, which may accrue against, be charged to, be recovered from or sought to be recovered from the city, its employees, officers and agents by reason of or on account of any personal injury, death or damage to property arising from the undersigned's use of the public right-of-way, whether such personal injury or death or damage to property is caused by the acts or omissions or negligence of the undersigned, or the undersigned's employees and agents or by the acts, omissions or negligence of any other person whatsoever, whether or not such persons are subject to the undersigned's control. The City, its employees, officers and agents shall not have to give the undersigned any specific type of notice of such claims.

## INSURANCE REQUIREMENT

The applicant shall furnish the City of Buena Vista a Certificate of Insurance which reflects a general liability limit of at least \$1,000,000 names the City of Buena Vista, its agents, and its employees as additional insured. The certificate must be approved by the Finance Department. As a provision of this permit the permittee shall, upon expiration of the permit, return the public right-of-way being used to be returned to its existing condition at the time of permit issuance. Should that not be accomplished within two (2) days of expiration, completion, revocation, or termination of the permitted activity, the City will perform the necessary work and the permittee agrees to reimburse the City for the associated costs.

By signing below, the permittee agrees to abide by the fees and conditions pertaining to the specific type of use being permitted, which are set forth in the attached documents.

The undersigned hereby agrees to abide by all City regulations controlling permitted use of the right-of-way, and further acknowledges that violation of permit conditions and or City Code will result in the revocation of this permit and the violator may be charged with a misdemeanor under the Virginia Code.
