# Façade Improvement Grant Program



## What is FIGP?

FIGP is a program to remove blight by assisting businesses and commercial property owners with improving building appearance and bringing grandfathered signs and parking into conformance with current code.

The program provides 50% reimbursement to commercial businesses or property owners for eligible renovation expenses with a maximum grant amount of \$7,500.

## What are the project criteria?

- Projects must be in the Mixed-Use district
- > Projects must be appropriate for the building and contribute to success of its current business use.
- > Projects must enhance a building's façade, creating an aesthetically pleasing and appropriate design.
- Projects must, where possible, preserve the architectural integrity of the structure and restore, when feasible, the original building façade.
- Projects must be in accordance with all applicable codes, ordinances, and guidelines.

### Is your business eligible?

Grant funding will only be awarded for exterior improvements to buildings within the Mixed-Use District, and are limited to the front, street- facing elevation of a building.

## **Application**

- Fill out and submit your application to Kristina Ramsey, Economic Development Coordinator, at <u>2039</u> <u>Sycamore Avenue</u> or by email at <u>kristina.ramsey@bvcity.org</u> with your \$50 application fee.
- Applications from tenants must include a copy of the lease and written approval from the property owner.
- > Applications must include photographs of the façade to be improved.

### Award

- Façade grants are reviewed by City Staff and the Economic Development Authority for the City of Buena Vista.
- Grants are awarded on a first come, first serve basis, as funds are available throughout the fiscal year.
- Project must be completed within one year from the date of approval; extensions may be given on projects that are actively under construction.
