- C. L and A Equipment testing, and certification at least 30 days before the November 2021 Election (State Law 24.2-632)
  - D. Security/Health Plan Chairman will review polling place Health/Security plan with the Sheriff, Police Chief, and Commonwealth Attorney 10/14 days before November 2021 Election
