#### **ADG #1: PLEDGE OF ALLEGIANCE AND PRAYER:**

Councilman Cooper delivered the opening prayer.

#### **ADG #2** APPROVAL OF THE AGENDA:

Councilman Cooper made motion to approve the agenda, seconded by Vice-Mayor Hickman, carried by Council.

### 1.) **Mayor**:

None.

# 2.) City Manager:

Mr. Tyree said he had made a mistake when doing the agenda. He had listed December 2nd as a Council meeting with the understanding that Council would have their scheduled December 16th meeting.

Mayor Fitzgerald opined that he would rather have the regular Council meeting on December 2nd and cancel the December 16<sup>th</sup> meeting.

Mr. Tyree suggested that Council look at the agenda a couple of weeks before the December 2nd meeting and if it is not a lot of things on the agenda, we can keep the meeting at the regular time of 6:00 p.m. It was decided the December 2nd Council meeting will begin at 5:00 p.m., not 6:00 p.m. Mr. Tyree said that he, Tom, and Kristina had a meeting with DHCD, the Department of Housing and Community Development about the downtown revitalization grant. They are still meeting and discussing the grant. He advised that he has a meeting with Hunter Young, Brian

Kearney, and himself week after next with Rural Development to discuss some grant loans and some different options the City will have in regard to the WWTP. Councilman Coffey said there have been a couple of people come in since the meeting started and wanted to know if they should go back on the agenda to see if they wanted to discuss anything.

#### 3.) City Attorney:

Mr. Kearney said we are meeting VDH to consider other grants for which we may apply.

#### 4.)Council Committee/Representative:

Councilman Coffey asked if it would be appropriate for him to comment on the ARP money that we are going to receive and what we have left. They mentioned it in the work session that Council had if we could pay for things and do things with the ARP money to lower the actual amount of money the City will have to borrow. He opined if we could inspect the tanks, repair the roofs on the digester building, the press building and the digester roof itself it would lower the cost. Last year a brand new circular floating roof was at least \$170,000.00. To repair the roof, it would be \$130,000.00 to \$140,000.00. We would be better off with a new roof at a cost of \$170,000.00.

Mr. Kearney replied to Councilman Coffey, but his reply could not be heard on the recording.

Councilman Coffey wanted to know if it is a possibility that the City will not have to borrow money.

Mr. Kearney said it all depends on how many grants and other funds we receive.

Mr. Tyree said it is important to note also the timeframes involved. If we would do work tomorrow, we want to make sure it is in the timeframe that vindicates the DEQ, USDA uses it as an in-kind match. That is an important thing also. If we did the work tomorrow and we do not apply for a grant until next year, they will not take that what we did now even though we would use ARP funds. It has to be within a certain timeframe.

Councilman Coffey wanted to know if Council has already approved the money to fix the digester roof.

Mr. Tyree said that money has already been approved. That would not count as an in-kind match towards this project.

Councilman Staton said we will be ahead of other localities because we already have our engineering work done.

Again Mr. Kearney replied but his reply could not be heard on the recording.

Councilman Coffey advised that he talked to Ronnie Campbell at Mountain Days, and he said that he was trying to get us as much money as he possibly can.

Councilman Henson said it has been a busy couple of weeks. Workforce Development talked about the possibility of a job fair in the Spring. The jobs are there but we do not have the personal to fill them. We have about 1,200 empty

spaces in Rockbridge County. He thanked Kristina, Millie and the others that helped with the downtown trick or treaters. Millie and the campers had another great event at the park. He gave special thanks to the Buena Vista Police Department and the Buena Vista Fire Department for keeping the traffic moving and organized. There was a concert at the park on Friday night to raise money for the food bank. We have 2 Christmas open houses coming up this weekend. They had a good Public Works/Public Safety meeting talking about seasonal changes and equipment. There was also a good Parks and Recreation meeting talking about events and maintenance projects. A lot of the things they looked at are low cost or no cost. There will be no more meetings with those two groups until next year unless something arises.

Mr. Tyree wanted to give a special thank you to the Stone Church of the Brethren for donating fencing for Penny Park that was vandalized.

Councilman Coffey also spoke about the food bank saying it was a great success. After all of the expenses the food bank got either \$2,500.00 or \$2,800.00.
